The objectives of the Erasmus VET Education Accreditation Project and the Call-1 are:

1. Improve foreign language skills (especially English language skills) of vocational education learners, graduates, vocational education specialists;
2. Enhance professional skills and intercultural communication skills of HOTEL SCHOOL vocational learners and graduates;
3. Familiarize to the latest technologies in the hospitality industry by vocational education learners, graduates, vocational education specialists;
4. Strengthen the link between HOTEL SCHOOL and the labour market (employers in EU countries) for promoting the employment of vocational education learners and graduates;
5. Foster the connection of HOTEL SCHOOL with educational institutions of a similar profile in other EU countries for solving common problems.

Number of competition mobilities: The competition includes **2 Teaching and Training Assignment Mobilities of VET education specialists with duration 22 (twenty two) days** each mobility.

Mobility Schedule: Individual schedule for 22 days mobility of each participant will be arranged during the period **from May 31, 2022 to September 2022 (or July 2022 to October 2022)**. The 2 (two) travel days will be added to the overall schedule.

Place of Mobility: Italian Hospitality School www.hoschool.it, Via Lima 7, 00198 Roma, in the diplomatic center of Roma.

Place of Living: accomodation upon your choice from funded daily support.

Teaching Assignment at: Italian Hospitality School www.hoschool.it upon individually developed programme for teaching courses.

The participants are offered and the following will be covered:

- Travel tickets from Riga to Roma and from Roma to Riga, plus transfer to Roma from the airport and from Roma to the airport; to the maximum limit of 275 EUR;
- Daily support sum 144 EUR per 1.-14. day, 101 EUR from 15.-22. days;
