"HOTEL SCHOOL" Viesnīcu biznesa koledža (HOTEL SCHOOL Hotel Management College) announces the Call-2 for the Erasmus funding in the framework of the project No. 2025-1-LV01-KA131-HED-000312975 for **Staff Mobility for Teaching in Spring Semester 2026**.

The objectives of the Erasmus ECHE and the Call-2 are:

HOTEL SCHOOL Modernisation and Internationalisation Strategy includes nine strategic directions for long-term goals with defined expected performance indicators.

I: The College Modernisation and Internationalisation Plan with partner selection criteria and annual updates.

II: The College Erasmus+ ECHE Charter for Higher Education 2021-2027.

III: Promotion of students' integration into the European and international labour markets – to motivate students to complete traineeships in high-level European and international hotels, thus promoting their integration into the European and international labour market.

Activities of the mobility to be supported: 1 incoming Mobility to Latvia for Higher Education Teaching Staff for delivery of a study course "Sustainable Hospitality Practice" in blended study mode:

- a physical mobility period from 19.05.2026 to 23.05.2026, equal to 5 days
- 4 funded travel days
- a virtual component from 27.02.2026 to 15.05.2026 (on Fridays from 10:00 to 11:30 EET in HOTEL SCHOOL Hotel Management College's e-learning environment www.e-hotelschool.lv)

Place of Mobility: HOTEL SCHOOL Hotel Management College (Riga, Latvia)

Financial support for the participants from Ukraine:

The financial support is calculated following the funding rules indicated in the Erasmus+ Programme Guide 2024 version. The participant will receive a financial support from Erasmus+ EU funds **for 9 mobility days**. The number of days will be equal to the duration of the physical mobility period and travel days.

The organisation shall provide the participant the total financial support for the mobility period and travel days in the form of a payment of **2253,00 EUR** including:

- European Commission Erasmus funding for accommodation & subsistence in the amount of 1530.00 EUR
- European Commission Erasmus funding for green travel in the amount of 417.00 EUR
- State budget of Latvia additional funding for teaching mobility in the amount of 306.00 EUR

The funding will be split in 2 parts. Second part will be paid after the completion of the physical mobility.
